Whereas, recommendations of these Candidates were kept withheld for want of certain documents,

Whereas, SSB vide order No. 466-SSB of 2018 dated 12.11.2018 has cancelled selection of these candidates as void ab-initio.





Whereas, against these 05 Candidates (OM=03, RBA=01 and ST=01) only 03 candidates (OM=03) are available in waiting list.

Whereas, Clear cut recommendation has been furnished by the SSB in favour of **Sh. Jasmeet Singh S/o Sh. Darshan Singh R/o Mohalla Gita Bhawan W.No.9 H.No. 53 Tehsil Haveli District Poonch and Sh.Darvinder Singh S/o Sh. Tarlok Singh R/o Mohalla Khakha Nawan Ward No. 17 House No. 53 District Poonch** who shall be deputed for undergoing one year's ACC training in Northern Zonal Accountancy Training Institute, Jammu.

During one year's ACC training the candidates shall be entitled to stipend as admissible under rules.


The selectees shall report to the Principal, Northern Zonal Accountancy Training Institute, Jammu, within a period of 21 days from the date of issuance of this order alongwith the following certificates/documents in original:-

- i. Academic/Technical Qualification Certificate.
- ii. Date of Birth Certificate.
- iii. Health Certificate issued by Competent Authority.
- iv. Permanent Resident Certificate.
- v. Relevant Category Certificate.
- vi. Certificate from General Manager of the concerned District Industries Centre and Deputy Director Employment, to the effect that No Loan under Self Employment Scheme has been taken by the appointee.

In case the selectees fail to join within the stipulated period of 21 days, their appointment shall stand cancelled without any further notice.

The appointment shall be subject to the following conditions:-

- (a) The selectees shall give undertaking in the shape of an Affidavit to the effect that in case any adverse report about their Character and Antecedents is received from the Additional Director General of Police, CID, J&K, to whom a reference shall be made by the Department, their appointment shall itself stand cancelled ab-initio and they shall have no claim of their appointment.
- (b) The verification of all required certificate(s) viz; Academic Qualification Certificate, Date of Birth Certificate, Health Certificate, Permanent Resident Certificate, Category Certificate (wherever applicable), Certificate from General Manager of the concerned District Industries Centre and Deputy Director Employment, to the effect that No Loan under Self Employment



Scheme has been taken by the appointees from the concerned Issuing Authority to be got done by the Principal of the training Institute.

The stipend of the selectees shall not be drawn and disbursed to them unless a satisfactory report in respect of (a) and (b) above is received.

After successful completion of one year's ACC training in Northern Zonal Accountancy Training Institute, Jammu, they shall be formally placed as Accounts Assistants in PB-1, ₹5200-20200 + Grade Pay ₹2800 (Pre-revised)/ Level-5 (29200-92300). Their service shall be regulated under the "Rules for Admission in the Accountancy Training Institute for the various Accountancy Courses and Examinations thereof" laid down in Schedule XI of J&K CSRs Vol-II and "J&K Subordinate Accounts Service Rules".
