Sub: Adjustment of the Accounts Assistant (Apprentice)
against the post of Accounts Assistant.

Order No. **23** - Accts of 2017
Dated :- **27.01.2017**

Whereas, among others, Shri Burnan Amin Vaid, S/o Mohd. Amin Vaid, R/o New Colony Bijbehara, was deputed for one year's ACC training (six month's theoretical and six month's practical) vide Order No.202-Accts of 2015 dated 21.05.2015 and joined in ATI, Srinagar on 06.06.2015;

Whereas, the said Accounts Assistant (Apprentice) completed his six month's theoretical training successfully and was subsequently deputed for first phase of two month's practical training in District Fund Office, Anantnag by the Principal, ATI, Srinagar vide his Order No. ATIS-S/015/90 dated 02.12.2015;

Whereas, Chief Accounts Officer, District Fund Office, Anantnag vide his No. CAO/DFO/Ang/Adm/1741-42 dated 02.03.2016 reported that the Accounts Assistant (Apprentice) did not join in his office for the practical training;

Whereas, Principal ATI, Srinagar vide No. ATI-S/619/2016 dated 26.03.2016 served a Show Cause notice to the Accounts Assistant (Apprentice) for clarifying his position who in response to the notice attended ATI, Srinagar on 25.04.2016 with a response that the absence from the training period w.e.f. **03.12.2015 to 25.04.2016** had been due to his ill health and also submitted Medical Certificates and an affidavit to that effect;

Whereas, Principal, ATI, Srinagar vide his letter No.ATI-S/2016/785 dated 17.05.2016 read with letter No. ATIS/2016/824 dated 20.05.2016 sought further instructions in the matter and after examination of the case who vide letter No. DGAT/E-III/PF-1189/86 dated 15.06.2016 was intimated

that the Apprentice may be allowed to continue in the Institute till completion of one year's training provided the reasons of absence quoted by him in his application dated 21.04.2016 were found based on facts and that the Apprentice shall be entitled to stipend only for one year;

Whereas, the Apprentice was further deputed for practical training in Treasury, Bijbehara, Anantnag and attended the Treasury w.e.f. 23.06.2016 to 15.10.2016 as per Attendance Certificate issued by the Treasury Officer, Treasury Bijbehara;

Whereas, the Accounts Assistant (Apprentice) was supposed to report back on 16.10.2016 in ATI, Srinagar but he reported on 22.12.2016 with the application that after getting relieved from Treasury Bijbehara on 15.10.2016 he suddenly developed some health problem and was advised by the consultant Doctor to take complete bed-rest from 16.10.2016 to 21.12.2016 and produced a Medical Certificate and an Affidavit to this effect;

Whereas, the Principal ATI, Srinagar vide his No. ATIS/2016/1241 dated 27.12.2016 intimated that the Accounts Assistant (Apprentice) was going to complete one year's ACC training on 03.01.2017 and requested to consider the case for his placement against the post of Accounts Assistant on health grounds and completion of one year's ACC training; and

Whereas, the case was examined in the Department under sub-rule II-A of Rule 11 of Schedule XI of the Jammu and Kashmir Civil Service Regulations, Vol-II and has been found covered within the said Rules.

In view of above and consequent upon completion of one year's ACC training (six month's theoretical and six month's practical) in Accountancy Training Institute as intimated by the Principal, ATI, Srinagar, vide his letter No. ATIS/2016/1241 dated 27.12.2016 **Sri Burhan Amin Vaid, S/o Mohd. Amin Vaid, R/o New Colony Bijbehara** is hereby placed against the post of Accounts Assistant and he shall report in the office of the Director, Accounts and Treasuries, Kashmir for his posting after getting properly relieved from the Training Institute.

He shall be allowed the pay in the Pay Band PB-1, ₹5200-20200 + Grade Pay ₹2800 in terms of SRO 93 dated 15.04.2009, read with SRO 266 dated 31.08.2009 from the

date he actually join in the office of the Director, Accounts & Treasuries, Kashmir.

His Annual Increment shall be governed in terms of the provisions laid down in SRO 160 dated 10.05.2006 till he qualify the A.C.C Examination to be conducted by the J&K Public Service Commission.
