Whereas, among others, Shri Rajat Chib, S/O Shri Jagdish Singh, R/O Budwal Akhnoor Jammu and Shri Gursharn Singh, S/o Shri Inderjeet Singh, R/o Nanak Nagar Jammu, were selected as Accounts Assistants (Apprentices) in District Jammu under ALC and OM Categories, respectively by the J&K Services Selection Board vide their No. referred to above;

Whereas, recommendations in respect of these candidates were kept withheld by the Services Selection Board subject to clarification from Competent Authority with regard to residential district; and

Whereas, the Secretary, J&K Services Selection Board vide his letter Nos. SSB/Sel/ Secy/2017/3450-52 dated 22.03.2017 and SSB/Sel/Secy/2017/3542-44 dated 24.03.2017 has conveyed that the recommendations which were kept withheld in respect of Shri Rajat Chib, S/O Shri Jagdish Singh, R/O Budwal Akhnoor Jammu and Shri Gursharn Singh, S/o Shri Inderjeet Singh, R/o Nanak Nagar Jammu are now released in their favour.

Consequent upon release of recommendations by the J&K Services Selection Board, Jammu vide their communications quoted above, **Shri Rajat Chib, S/O Shri Jagdish Singh, R/O Budwal Akhnoor Jammu and Shri Gursharn Singh, S/o Shri Inderjeet Singh, R/o Nanak Nagar Jammu selected under ALC Category and OM Category in District Jammu by the Services Selection Board vide their No. referred to above** are deputed for undergoing one year's Accounts Clerk's Course Training (six month's theoretical and

six month's practical) in Northern Zonal Accountancy Training Institute, Jammu. During the training period they shall be entitled to stipend as admissible under rules.


The selectees shall report to the Principal, Northern Zonal Accountancy Training Institute, Jammu, within a period of 21 days from the date of issuance of this order alongwith the following certificates/documents in original:-

1. Academic/Technical Qualification Certificate.
2. Date of Birth Certificate.
3. Health Certificate issued by Competent Authority.
4. Permanent Resident Certificate.
5. Relevant Category Certificate.
6. Certificate from General Manger of the concerned District Industries Centre and Deputy Director Employment, to the effect that no Loan under Self Employment Scheme has been taken by the appointee.

In case the selectees fail to join within the stipulated period of 21 days, their selection shall stand cancelled without any further notice.

The appointment shall be subject to the following conditions:-

- (a) The selectees shall give undertaking in the shape of an Affidavit to the effect that in case any adverse report about their Character and Antecedents is received from the Additional Director General of Police, CID, J&K, to whom a reference shall be made by the Department, their appointment shall itself stand cancelled ab-initio and they shall have no claim of their appointment.
- (b) The verification of all required certificates viz; Academic Qualification Certificate, Date of Birth Certificate, Health Certificate, Permanent Resident Certificate, Category Certificate, Certificate from General Manger of the concerned District Industries Centre and Deputy Director Employment, to the effect that No Loan under Self Employment Scheme has been taken by the appointee from the concerned Issuing Authority to be got done by the Principal of the training Institute.



The stipend of the selectees shall not be drawn and disbursed to them unless a satisfactory report in respect of (a) and (b) above is received.

After successful completion of one year's ACC training at Northern Zonal Accountancy Training Institute, Jammu, they shall be formally placed as Accounts Assistants in PB-1, ₹5200-20200 + Grade Pay ₹2800 against the post of Accounts Assistants. Their services shall be regulated under the "Rules for Admission in the Accountancy Training Institute for the various Accountancy Courses and Examinations thereof" laid down in Schedule XI of Jammu and Kashmir Civil Service Regulations Volume-II and "Kashmir Subordinate Accounts Service, Rules".
