**Subject:** Deputation of Accounts Assistants (Apprentices), selected under Hon'ble Prime Minister's Special Package for Kashmiri Migrants, for undergoing Accounts Clerk's Course (ACC) Training.

Whereas, among others, the 08 selectees, listed in Annexure-A to this Order, recommended by the Services Selection Board for appointment against the posts of Accounts Assistants vide their Nos. referred to above, were deputed for undergoing one year's ACC training vide Order No. 274-Accts of 2015 dated 01.07.2015 and 337-Accts of 2015 dated 21.08.2015;

Whereas, they were supposed to join in Principal, Accountancy Training Institute, Srinagar within a period of 21 days from the date of issue of the Order;

Whereas, as intimated by the Principal, Accountancy Training Institute, Srinagar vide their Nos. ATIS/015/183-84 dated 20.08.2015 and ATIS/015/264 dated 15.10.2015, these selectees fail to join in the training Institute within the stipulated period of 21 days;

Whereas, a notice was issued vide No. DGAT/E-III/G-18/276 dated 10.12.2015 through print media and official website informing the concerned selectees/absentee that consequent upon their failure to join/report in the concerned training Institute, their selection shall be cancelled and the Waiting List furnished by the Services Selection Board shall be operated against their places. These selectees/absentee were also given a chance to file their objections, if any, to this effect within seven days from the date of issuance of the aforementioned notice;

Whereas, no objection has been filed by the concerned absentee in this behalf within the stipulated period which made it clear that they have no objection to the cancellation of their selection as

Accounts Assistants, recommended by the Service Selection Board vide their Nos. referred to above.

In view of above, sanction is hereby accorded to the:-

- i. cancellation of selection/deputation for one year's ACC training in respect of 08 candidates, listed in Annexure-'A' to this order, who were selected by the Service Selection Board as Accounts Assistants in Finance Department in the Main Selection List vide its Nos. referred to above; and**
- ii. deputation of 05 candidates, listed in Annexure-B to this order, selected by the Service Selection Board as Accounts Assistants in Finance Department in Waiting List vide its Nos. referred to above, for one year's ACC training in Accountancy Training Institute, Srinagar. However, the deputation orders in respect of other 03 eligible candidates, in Waiting List shall be issued as and when their recommendation are released by the Service Selection Board.**

During the training period these **05** candidates shall be entitled to stipend as admissible under rules.

After successful completion of one year's ACC training in Accountancy Training Institute, Srinagar, they shall be formally placed as Accounts Assistants in PB-1, ₹5200-20200 + Grade Pay ₹2800. Their services shall be regulated under the "Rules for Admission in the Accountancy Training Institute for the various Accountancy Courses and Examinations thereof" laid down in Schedule XI of J&K CSRs Vol-II and "J&K Subordinate Accounts Service Rules".

The selectees shall report to the Principal, Accountancy Training Institute, Srinagar, within a period of 21 days from the date of issuance of this order. They shall be allowed to join and their joining report shall become effective only after they execute agreement in the "Form" prescribed in **Annexure-'C'** under Jammu and Kashmir, Kashmiri Migrants (Special Drive) Recruitment Rule 2009, introduced vide SRO 412 of 2009 dated 30.12.2009, besides production of the following certificates/documents in original:-

1. Academic/Technical Qualification Certificate.
2. Date of Birth Certificate.
3. Health Certificate issued by Competent Authority.
4. Permanent Resident Certificate.
5. Relevant Category Certificate.
6. Certificate from General Manger of the concerned District Industries Centre and Deputy Director Employment, to the effect that no Loan under Self Employment Scheme has been taken by the appointee.



7. Migration Certificate of being a Kashmiri Migrant duly issued by Commissioner, Relief & Rehabilitation (Migrant), Jammu.

In case any of these selectee fail to join within the stipulated period of 21 days, his/her selection shall stand cancelled without any further notice.

The appointment shall also be subject to the following conditions:-

- (a) The selectees shall give an undertaking in the shape of an Affidavit, duly authenticated by a Judicial Magistrate 1<sup>st</sup> Class, to the effect that in case any adverse report about their Character and Antecedents is received from the Additional Director General of Police, CID, J&K, to whom a reference shall be made by the Principal concerned, their appointment shall itself stand cancelled ab-initio and they shall have no claim of their appointment.
- (b) The verification of Qualification Certificates/Migration Certificates/Reserved Category Certificates (wherever applicable) from the concerned Issuing Authority to be got done by the Principal concerned.

The stipend of the selectees shall not be drawn and disbursed to them unless a satisfactory report in respect of (a) and (b) above is received.

In case any selectee migrates from Kashmir Valley at any time during his/her service tenure, for any reason whatsoever, his/her selection/service shall stand terminated without any notice by itself by the action of his/her migration.







**AGREEMENT FORM**

Whereas, the Government has decided to provide employment to un-employed Kashmiri Migrant youth in terms of Jammu and Kashmir, Kashmiri Migrants (Special Drive) Recruitment Rules, 2009.

Whereas, vide Government Order No. \_\_\_\_\_ dated \_\_\_\_\_ in the executor has been appointed on probation as \_\_\_\_\_ in the Department \_\_\_\_\_ subject to execution of this Agreement, and inter-alia on the explicit condition that his selection as such shall subsist only so long as he/she serves in the Kashmir Valley;

Whereas, that the selectee shall be considered for regularization on the basis of his performance and satisfactory completion of period of probation in accordance with aforementioned rules;

Whereas, that the selectee agrees to serve in Kashmir Valley and will at no stage opt or seek for transfer outside Kashmir Valley;

Whereas, the selectee agrees that in case he/she migrates again from Kashmir Valley at any stage for any reasons whatsoever, he/she will stand automatically terminated from the service and shall have no claim against any post under the State;

Whereas, if the selectee wilfully neglects or refuses to perform his/her duty in Kashmir Valley the Appointing Authority shall immediately terminate his/her service; and

Whereas, the selectee will at no stage seek or opt for transfer outside the Kashmir Valley.

Now, therefore, I accept the said terms and conditions of selection.
