Subject: **Un-authorized absence of Mr. Ravi Kumar Sharma, Incharge Assistant Accounts Officer, PMGSY Division Thathri.**

**Government Order No: 171-F of 2022**  
**Dated: 30.06.2022**

Whereas, Shri Ravi Kumar Sharma S/o Shri Ram Dass Sharma, R/o Jandhari, Tehsil & District, Udhampur, was placed as Incharge Assistant Accounts Officer vide Order No. 310-Accts of 2014 dated 15.07.2014 and posted in PMGSY Division II (Thathri) Doda.

Whereas, he was relieved on 08.07.2016 by Chief Accounts Officer, Migrant Cell, DSE Jammu vide his No.DSEJ/Mig/Actts/200-03 dated 08.07.2016 and advised to report to the Executive Engineer PMGSY Division II (Thathri) Doda for further duties.

Whereas, he joined in the office of Executive Engineer PMGSY Division II (Thathri) Doda on 09.07.2016 and attended his duties there w.e.f 09.07.2016 to 10.09.2016.

Whereas, he suddenly left the station un-authorizedly without permission w.e.f 11.09.2016 onwards.

Whereas, a notice in this regard was served to him by Executive Engineer PMGSY Division Thathri Doda, vide No. PMGSY/D/T/1040-43 dated 03.11.2016, to resume his duties.

Whereas, two further notices were served to him vide No.DGAT-E-I/9/2021-01/1/7902/2021/34 dated 31.12.2021 and DGAT-E-I-I/10894/2022/39 dated 10.02.2022 and published in State Times Newspaper on January 04 2022 and February 13 2022 respectively.

Whereas, a final notice was also served to him vide No.DGAT-E-I/9/2021-01/15405/63 dated 08.04.2022 through print media which was published in leading newspaper Daily Excelsior on April 15, 2022.

Whereas, in response to the final notice he responded vide his reply dated nil, indicating his inability to resume his duty immediately and requested for grant of 15 days time on humanitarian grounds to join his duties owing to ailment of his mother.

Whereas, his reply has not been found satisfactory keeping in view his continuous and un-authorized absence for more than five year which amounts to loss of appointment.

Now, therefore, in terms of Article 113 and 128 of J&K Civil Services Regulations Vol-I, 1956 the services of Shri Ravi Kumar Sharma S/o Shri Ram Dass Sharma, R/o Jandhari, Tehsil & District, Udhampur, Incharge Assistant Accounts Officer are terminated w.e.f. 11.09.2016.


