***In chapter 4.9 and 5.7 of the Book of Financial Powers, S.Nos. 1 &
6 and S.Nos. 1,2 & 4 respectively, shall be amended as under:-***

- I. *In S.No.1 of Chapter 4.9, the existing figures and words "Rs. 500 lac", appearing under the Column "Extent to which assent is given", shall be substituted by the figures and words " Rs.750 lakh" and;*

In Note 3 below clause (b) under the Column, "Extent to which assent is given" corresponding to S.No. 1, the figures and words, "Rs.500 lacs", shall be substituted by the figures and words, "Rs.750 lakh".

- II. *In S.No. 6 of Chapter 4.9, the existing figures and words "Rs.500 lacs", appearing in clause (a) under the Column, "Extent to which assent is given", shall be substituted by the figures and words, "Rs.750 lakh".*

III. In Chapter 5.7 Serial No.1,2 and 4 shall be recast as under:

(ii) Up to ₹5.00 lakh for works pertaining to their departments within their jurisdiction.</i>

2	To accord Administrative approval to individual works other than residential buildings.	(i) Chief Engineer (ii) Superintending Engineer	Up to ₹400.00 lakh. Up to ₹150.00 lakh.
4	To accord Administrative Approval to estimates of capital expenditure on the construction of residences for Government servants to meet the requirements of their respective departments	(i) Major head of Departments (ii) Chief Engineer public Works (iii) Superintending Engineer	(i) Up to ₹30.00 lakh. (ii) Up to ₹50.00 lakh. (iii) Up to ₹25.00 lakh.


