- Last day/time for receipt of bills at treasuries shall be Thursday, 27th of (i) March, 2025 upto 04.00 P.M. The Treasury Officers shall communicate consolidated liability on 27<sup>th</sup> by 05.30 P.M. positively.
- (ii) All treasuries, including Civil Secretariat Treasury and Sub Treasury, New Delhi, shall remain functional on Saturday 29th of March, 2025.
- (iii) All treasuries shall remain open on March 30th 2025(Sunday) and March 31st (Monday), for receipt of cash/remittances only.
- (iv) The bills / claims so presented in the Month of March are liable to Special Audit, wherever required.
