Subject :- Establishment of Date of birth in favour of Shri. Pardeep Sen, Ex-Accounts Officer, District Treasury Kishtwar.

Government Order No. ²⁴⁷-F of 2024
Dated: 26 07.2024

Whereas, the pension case of Sh. Pardeep Sen, Accounts officer who retired on Superannuation as on 30.09.2023 and died on 05.10.2023 was submitted by Pension Sanctioning Authority to the Principal Accountant General (A&E), J&K Jammu for Authorization of Pensionary benefits in his favour.

Whereas, Principal Accountant General (A&E), J&K, Jammu vide letter No. PNR/C-1/2023-24/1381-83 dated 11.10.2023 observed as under:-

- a. Perusal of the 1st Page of service book of Sh. Pardeep Sen revealed that his date of birth, initially recorded has been mutilated/overwritten in words as well as in figures.***
- b. Besides, the name of the official mentioned in the photocopy of the matriculation certificate is Pardeep Kumar Sen Whereas the 1st page of the service book depicts as Pardeep Sen.***

Whereas, on verification of available service records of the ex-officer, it revealed that the mutilation in date of birth in his service book as pointed out by Audit on spot and his date of birth was recorded as 19.09.1963 in the service book based on Matriculation Certificate issued by Jammu and Kashmir Board of School Education.

Whereas, as per the available office records like seniority lists issued from time to time, Annual Performance Reports of different period and Retirement memo, the date of birth of the officer is recorded as 19.09.1963 and due date of retirement is 30.09.2023 and hence the officer has superannuated on due date.

Whereas the second query raised by the AG Office is concerned, the available official records like Appointment order, Annual Property Return Statements of different periods, Domicile Certificate, CPIS date and first page of Service book of the said officer reveals that the name recorded in all these documents is Pardeep Sen. However, there is only one document where the name of the officer is recorded as Pardeep Kumar Sen.

Whereas, an affidavit has been submitted by Sh. Sorab Sen S/o Pardeep Sen duly attested by 1st Class Magistrate declaring that both Pardeep Sen and Pardeep Kumar Sen is one and the same person.

Whereas, the case was taken up with the Finance Department and vide U.O No. FD-Code/138/2022-02 dated 09.05.2024, Finance Department advised as under: -

- i. In terms of Sub clause 'a' of Article 35-AA, date of birth is to be accepted by the Appointing Authority. As Such, the DGAT has to establish the date of birth of the retired employee on the basis of Matriculation Certificate.
- ii. With regard to correction in name and parentage of deceased officer in the service records, Directorate may seek additional identity proof and verify relevant records in consultation with Board of School Education and the Recruitment Agency and carry out the requisite changes after being satisfied about the genuineness.

Whereas, the matter was taken up with J&K Board of School Education vide Letter No. DGAT/CAE-442/59/7367816 dated 10.05.2024 and in response J&K Board of School Education vide no. F(Veri-B) JD/2024/1434 dated 24.05.2024 confirmed the date of birth of Sh. Pardeep Sen as 19.09.1963 which is in conformity with the date of birth recorded in the first page of service book and other records.

Whereas, vide office letter no. DGAT/CAE-442/60/7367816 dated. 10.05.2024, Principal, Northern Zonal Accountancy Training Institute, Jammu was asked to provide personal file of Sh. Pardeep Sen. From the personal file of the ex-officer provided by Principal, NZATI vide No. A/Zonal/PF/1986/ACC/113 dated 10.05.2024, it transpires that name mentioned in the first appointment order is Pardeep Sen S/o Bhoop Ram Sen.

Whereas, other documents like PAN, Aadhar Card, Ration Card, Domicile Certificate, CPIS date, APR's and seniority list issued from time to time were also checked and it was found that the name recorded in all these document is Pardeep Sen.

Whereas, the case was examined in light of factual details, documents made available by Principal NZATI, J&K Board of School Education, identity proof, affidavit submitted by Sh. Sourab Sen S/o Sh. Pardeep Sen, Service records of the ex-officer and extant rules governing the subject. It came to fore that the date of birth of Sh. Pardeep Sen is 19.09.1963 and he has retired on due date. Besides this, it is also established that Sh. Pardeep Kumar Sen and Sh. Pardeep Sen is one and the same person.

Now, therefore, in light of factual position and the rules governing the subject, the date of birth of Sh. Pardeep Sen, ex-Accounts Officer retired on superannuation on
