As recommended by the J&K Services Selection Board, Jammu vide communication referred above, sanction is hereby accorded to the deputation of Miss. Asma Rashid D/O Abdul Rashid Sofi R/O Muniwar Khapora Anantnag, Kashmir to Accountancy Training Institute, Srinagar for one year's ACC training (six month's theoretical and six month's practical).

During one year's ACC training period the candidate shall be entitled to stipend as admissible under rules.

The selectee shall report in the respective training Institute within a period of 21 days from the date of issuance of this order along with the following certificates/documents in original:-

Academic/Technical Qualification Certificate.

ii. Date of Birth Certificate.

iii. Health Certificate Issued by Competent Authority.

iv. Permanent Resident Certificate/ Domicile Certificate.

v. Relevant Category Certificate.

VI. Certificate from General Manger of the concerned District Industries Centre and Deputy Director Employment, to the effect that No Loan under Self Employment Scheme has been taken by the appointee.

In case selectee fails to join within the stipulated period of 21 days, her appointment shall stand cancelled without any further notice.

The appointment shall be subject to the following condition:-

Verification of all required certificate viz; Academic Qualification Certificate, Date of Birth Certificate, Health Certificate, Permanent Resident Certificate/ Domicile Certificate, Category Certificate (wherever applicable), Certificate from General Manager of the concerned District Industries Centre and Deputy Director Employment, to the effect that No Loan under Self Employment Scheme has been taken by the appointee from the concerned Issuing Authority to be got done by the Principal of the training Institute.

The stipend of the selectee shall be drawn and disbursed upon satisfactory report in respect of above condition is received.

After successful completion of one year's training at Accountancy Training Institute, Srinagar, she shall be formally placed as Accounts Assistants in Pay Level-5 (29200-92300) against the post of Accounts Assistant. Her service shall be regulated under the provisions of "Rules for Admission in the Accountancy Training School for the various Accountancy Courses and Examinations thereof" laid down in Schedule XI of J&K CSRs Vol-II and "J&K Subordinate Accounts Service Rules".
