In continuation to this office order no 58-Acctts of 2024 dated: 20.06.2024 and as recommended by the J&K Services Selection Board, Jammu vide communication referred above, sanction is hereby accorded to the deputation of **30 candidates** forming Annexure A & B to this order in Northern Zonal Accountancy Training Institute, Jammu/ Accountancy Training Institute, Srinagar respectively for one year's ACC training (six month's theoretical and six month's practical).

During one year's ACC training period these candidates shall be entitled to stipend as admissible under rules.

The selectees shall report in the respective training Institutes within a period of 21 days from the date of issuance of this order along with the following certificates/documents in original:-

- i. Academic/Technical Qualification Certificate.
- ii. Date of Birth Certificate.
- iii. Health Certificate issued by Competent Authority.
- iv. Permanent Resident Certificate/ Domicile Certificate.
- v. Relevant Category Certificate.
- vi. Certificate from General Manger of the concerned District Industries Centre and Deputy Director Employment, to the effect that No Loan under Self Employment Scheme has been taken by the appointee.

In case any appointee fails to join within the stipulated period of 21 days, his/her appointment shall stand cancelled without any further notice.

The appointment shall be subject to the following condition:-

The verification of all required certificate viz; Academic Qualification Certificate, Date of Birth Certificate, Health Certificate, Permanent Resident Certificate/ Domicile Certificate, Category Certificate (wherever applicable), Certificate from General Manager of the concerned District Industries Centre and Deputy Director Employment, to the effect that No Loan under Self Employment Scheme has been taken by the appointee from the concerned Issuing Authority to be got done by the Principals of the concerned training Institutes.

The stipend of the selectees shall not be drawn and disbursed to them unless a satisfactory report in respect of above condition is received.

After successful completion of one year's training at Northern Zonal Accountancy Training Institute, Jammu/Accountancy Training Institute, Srinagar they shall be formally placed as Accounts Assistants in the Pay Level-5 (29200-92300). Their services shall be regulated under the provisions of "Rules for Admission in the Accountancy Training School for the various Accountancy Courses and Examinations thereof" laid down in Schedule XI of J&K CSRs Vol-II and "J&K Subordinate Accounts Service Rules".
